The proposed development provides for 2 development options - Option (A) and Option (B) as described hereunder:

Description of Development

Option A

- Construction of a single storey building for light Industry use with ancillary office space of c. 915 sq. m.
- Construction of a 2-storey building for office use of c. 1369 sq. m.
- Associated services including signage, cycle bays, landscaping, sculpture and boundary treatment.

• Or Option B

- Construction of the 2-storey building for office use building only as under Option A
- Associated services including signage, cycle bays, landscaping, sculpture and boundary treatment.

This Part 8 proposal relates to the redesign and modification of a previously approved Part 8 development on the site which comprised the construction of 2 no. buildings for light industrial and office use.

An Environmental Impact Assessment (EIA) Preliminary Examination, an Appropriate Assessment Screening, and a Waste Assessment Criteria (WAC) Report for the proposed development have been completed and are available for inspection.
