Men were fighting with poles outside a local café

FOOTAGE of men hitting each other with poles on Kennedy Street, Carlow last year was played at the start of an affray trial last week.

Guiseppe Torres (50) of The Towers, Graiguecullen and 39-year-old Marco De Felice of Barrowvale, Portlaoise appeared before Carlow District Court charged with affray outside Caffé500 restaurant on Kennedy Street, Carlow on 10 June last. Both men deny the charge.

CCTV footage, which was sourced by gardaí from OMG Studio, located across the road from Caffé500, was played at last Wednesday's sitting of Carlow District Court.

Manager of OMG studio Kamil Szymanski said he was working on the day of the incident and would be a client of one of the defendant's, Mr De Felice of Caffé500.

The video, which goes on for around five minutes, starts with Mr Torres throwing something towards Caffé500. He kicks at the door of Caffé500 before going back across the road. He goes into Caffé500 and emerges with what appears to be a piece of hoarding and strikes the window. Mr De Felice comes out of the restaurant with a stick and attempts to hit Mr Torres, who also has a

pole from the hoarding. The incident goes over and back on the road on Kennedy Street with cars passing by. A third shirtless man appears with a stick and attempts to hit Mr Torres.

At one point, the defendants can be seen grappling on the road. Matters seem to calm down with passers-by attempting to intervene, but Mr Torres, now shirtless, continues to remonstrate.

Four minutes into the video, gardaí arrive at the scene and arrest Mr Torres. Three gardaí are seen attempting to put Mr Torres into the garda van.

Solicitor for Mr Torres, Joe Farrell, took an interest in this section of video and noted that five to six seconds were missing. The video ends as gardaí are about to put Mr Torres into the garda van and cuts to the gardaí closing to the door. "I am not able to explain that. CCTV sometimes does that," said Mr Szymanski. He said he gave four or five

Evidence was also heard from Dr Denise Lyons that she was driving on Kennedy Street in slow traffic. Her niece and nephew called out that there was fight.

"I looked up and there were three gentlemen with sticks," she said. She noted that some of the men were wearing aprons. "I was trying to keep my eyes on the road, but then it spilled out onto the road."

Judge Carthy was told the case could take around two hours, with a number of garda and civilian witnesses to be called. The case was adjourned until 13 July.

Disqualified driver gets a further ban

A BALTINGLASS man was banned from driving for four years after a court heard he had been driving while disqualified. Samuel Sheridan (27) of Bawnogues, Baltinglass pleaded guilty to driving without insurance, a licence and failing to produce driving documents on the N80 in Graiguecullen on 7 July last.

Sergeant Hud Kelly said gardaí stopped Mr Sheridan's vehicle after he failed to indicate through two roundabouts.

"The defendant was asked for his licence but said he did not have it on him," stated Sgt Kelly.

Mr Sheridan said he would produce his driving documents in Baltinglass, but failed to do so. It later emerged that he had been serving a driving ban. Mr Sheridan had three previous convictions.

"He is in bother," admitted defending solicitor Joe Farrell.

Mr Farrell said his client was currently dealing with a thyroid cancer diagnosis and had recently been treated in hospital.

Mr Farrell said his client had been travelling to his girlfriend's house when the offence was detected.

Judge Geraldine Carthy imposed a two-month sentence, suspended for 12 months, for driving without insurance.

The defendant received a four-year driving ban for the same offence, while a €300 fine was handed down for the licence offence.

"To be fair, I think you have other challenges to be dealing with," said the judge.

Rathvilly man told he risks going to jail if he reoffends

A RATHVILLY man was given five months to avoid a custodial sentence at Carlow District Court recently. Jason Whelan (31) of Fr Cullen Terrace pleaded guilty to threatening, abusive and insulting behaviour at Fr Cullen Terrace on 3 July last.

Evidence was heard that gardaí had been carrying out a search in the area when the defendant became aggressive and attempted to fight gardaí. The defendant spat at one garda and called him a 'black P--i bastard'. The defendant then made lewd gestures with his penis, with members of the public, including children, present.

The defendant had 14 previous convictions, including for indecency and road-traffic offences. However, his solicitor Brendan O'Flaherty said he did not believe the court could judge his client like other people. The defendant had been involved in a serious road-traffic accident that resulted in a "change of personality", said the solicitor.

The case had been adjourned for a probation report, while Mr Whelan also entered a plea to possessing €5 worth of cannabis.

Judge Geraldine Carthy noted that the offences before the court could trigger a suspended sentence of nine months.

Mr O'Flaherty also submitted a "positive letter" from the defendant's addiction counsellor. The solicitor said that his client had replaced a reliance on cannabis with excessive alcohol consumption.

Judge Carthy said she was considering a custodial sentence, but would adjourn the matter for five months to see if Mr Whelan came to the attention of gardaí. If he does not, the judge said she would impose a suspended sentence; otherwise, Mr Whelan would face custody.

The case was adjourned until 21 September.
